

**MINUTES OF
REGULAR CITY COUNCIL MEETING
GLENNVILLE CITY HALL
TUESDAY, AUGUST 5, 2025
7:00 P.M.**

The regular scheduled council meeting was held in the City Hall Conference Room Tuesday, August 5, 2025.

I. CALL TO ORDER, INVOCATION, AND PLEDGE OF ALLEGIANCE

Mayor Weaver called the meeting to order, Fire Chief Barnard gave the invocation, and Public Works Director Fravel led the Pledge of Allegiance.

II. DISCUSSION / APPROVAL OF THE AGENDA

Mayor Weaver asked for a motion to approve the agenda as presented. A motion was made by Councilmember Waters, seconded by Councilmember Nobles and it passed unanimously.

III. PUBLIC COMMENTS:

This is the time we set aside for our citizens to comment on matters. We welcome and appreciate your comments or suggestions. Our purpose is to listen to what you tell us, and we will certainly take any comments you make under advisement. We do not answer questions at this time, nor do we reply to your statements at this time. The reason for this is that an individual council member cannot and should not attempt to commit the entire council to any position, and the council should not respond until it has all the information available on a specific matter.

Ground Rules:

- To be placed on the agenda, you must make your request to the City Clerk or City Manager by noon on the **Thursday** prior to the meeting. If a holiday falls around the meeting date, the deadline will be noon on **Wednesday** prior to the meeting day.
- Your comments are limited to five (5) minutes.

- If you have a complaint about an employee of the City, please discuss it with the City Manager first. The City Manager will advise the Council of the matter, and an executive session may be scheduled to discuss personnel issues.
 - You should avoid making any slander or defamation of someone's character or reputation. If such comments are made, there can be legal consequences that follow since this is a public meeting.
 - We prefer that you address matters that this council has the authority to deal with.
- **Reginald King wants to discuss the Heart of Georgia and the City Council involvement in the Trailer Ordinance. Do not attend**
 - **Stacey Johnson wants to discuss the upcoming sewer project that will potentially run through his property at 109 Hilltop Road.**

Stacey Johnson explained that he wanted to speak about the changing of the sewer lines on Hilltop Road. He explained that they had his property surveyed and now had lines marked through his yard where the new sewer system would go and one was through his driveway, which would hinder him from using his carport until the project was complete. He explained that him and his wife would have to park 30 foot off the road during that time. He said the questions he wanted to know was: How is the City sewer running through his property and why was it marked differently than what he was originally told? How would the City ensure that his property would look the same if not better than it was now, once the project was complete? How often had this situation with sewer lines running through private property come up before? He told the city worker that spoke with him that it was fine to do the project but he would require the city to get a binder. He explained that a binder was a sum of money set aside and if his yard was not put back the same if not better than it was before the project, he would keep the money. He explained that he did not want his yard to look like some of the yards did on Rushing Street after the water project. He also mentioned that he was told a sewer main would be placed in his driveway and that it could not go there because him and his wife would be driving over it and he did not want to bust it. He explained that he currently does not have any drainage issues in his yard and when it rains there was no standing water and he did not want any issues created. He understood that they couldn't do anything about it at that time but wanted to voice his opinion.

IV. DISCUSSION / APPROVAL OF CONSENT AGENDA

Mayor Weaver asked for motion to approve the consent agenda. A motion was made by Councilmember Nobles, seconded by Councilmember Waters and it passed unanimously.

V. DISCUSSION / APPROVAL OF POLICE OFFICER RECRUITMENT PLAN

This item was postponed.

VI. DEPARTMENT UPDATE

Police Chief Kicklighter explained that for the month of July the Police Department:

- Issued 11 citations and 2 warnings
- Completed 19 incident reports and 7 accident reports
- Had 329 calls for service
- Arrested 3 individuals resulting in 7 misdemeanors and arrested 1 individual resulting in 3 felonies

Fire Chief Barnard explained that the Fire Department responded to 8 calls for the month of July with 3 inside the city limits, 5 outside the city limits, and had 13 hours of operation.

Public Works Director Fravel explained that the water department completed 3 water taps, replaced 134 registers, completed 1 lift station repair for the month of July. He then explained that the street department pick up over 126 piles of limbs, over 100 bags of leaves, completed 1 road repair and 1 storm drain repair.

Councilmember Waters asked Public Works Director Fravel for an update on the project affecting Deloach Lane.

Public Works Director Fravel explained that the contractor was running tests on the new water lines and if all the test come back good, they would be tying in the new lines the next week.

VII. COUNCIL COMMENTS

Councilmember Nobles thanked everyone for coming to the meeting and the department heads for the work that they do.

Chamber Director Craft thanked the department heads for helping with the Back-to-School Bash.

Mayor Weaver thanked everyone for coming to the meeting.

VIII. EXECUTIVE SESSION TO DISCUSS LITIGATION

Mayor Weaver asked for a motion to go into executive session to discuss personnel. A motion was made by Councilmember Waters, seconded by Councilmember Miller and it passed unanimously.

Mayor Weaver asked for a motion to return to regular session. A motion was made by Councilmember Mcleod, seconded by Councilmember Waters and it passed unanimously.

IX. ADJOURN

With all items being handled, Mayor Weaver adjourned to meeting.
