### II. DISCUSSION / APPROVAL OF THE AGENDA

VIII. DISCUSSION / APPROVAL FOR THE REMOVAL, CUTTING, AND/OR DESTROYING OF WEEDS OR OTHER UNSIGHTLY GROWTHS BY OR FOR THE CITY ON PARCEL G04 020, LOT ON GREEN STREET, DUE TO THE REFUSAL BY PROPERTY OWNER UPON BEING NOTIFIED PURSUANT CITY ORDINANCE CHAPTER 30, SECTION 8

Mayor Weaver asked for a motion for the removing, cutting, and/ destroying of weeds or other unsightly growths by or for the City on parcel G04 020, lot on Green Street, due to the refusal by property owner upon being notified pursuant City Ordinance Chapter 30, Section 8. A motion was made by Councilmember Miller, seconded by Councilmember Nobles and it passed unanimously.

IX. DISCUSSION / APPROVAL OF RESOLUTION #25-14 TO ADD MEMBERSHIP IN A FUND OF GEORGIA INTERLOCAL RISK MANAGEMENT AGENCY (GIRMA)

**NOTE:** HB 451 was signed into law on 5/1/2024 requiring all public entities to maintain PTSD insurance coverage on all first responders. The Georgia Municipal Association (GMA) has offered coverage for the compliance of this law. This resolution is approval / disapproval for the Mayor and City Clerk to execute the documents to enroll in this program through GMA.

Mayor Weaver asked for a motion for approval of Resolution #25-14 To add membership in a fund of Georgia Interlocal Risk Management Agency (GIRMA). A motion was made by Councilmember Waters, seconded by Councilmember McLeod and it passed unanimously.

#### X. COUNCIL COMMENTS

Councilmember Waters stated that the Art and Wine Festival was a huge success and recognized Lisa Barry, Casey Butler, and the others ladies in the group for their hard work.

Councilmember Miller thanked everyone for what they did.

City Manager Dansby reminded everyone of Veterans Day, stated that he hoped everyone recovered from the storm, thanked all the City workers for the hard work of cleaning up after the storm.

Councilmember Waters asked for an update on debris pickup through the contractors.

City Manager Dansby explained that he would start forwarding all emails he received and that there were some discrepancies with the amount of debris from Glennville but it was being worked out. He stated that as of today Glennville debris was measured at 22,000 cubic yards. He explained that Glennville had completed a FEMA application and had an onsite meeting on November 19, 2024.

Fire Chief Barnard explained that it was a busy month for the fire department with a total of 25 calls and 1 was a structure fire.

Chamber Director, Kim Craft, thanked everyone for the support with the pancake supper and told everyone to get ready for Celebration of the Season.

Mayor Weaver reminded everyone of Veterans Day and explained that the Art and Wine festival was a huge success. He also recognized Casey Butler and Lisa Barry for their hard work on the Downtown Stage area.
